

RELEASE AND INDEMNITY AGREEMENT
This document will affect your legal rights and liabilities.
Please read carefully before signing.

To: The Friends of Sunnybrook Farm Society

I, _____ am aware that there are many inherent risks, dangers and hazards to which my child/ or the children that I am responsible for, may be exposed as a result of his/her attendance at the Day Camp program offered at the Sunnybrook Farm Museum (hereinafter also referred to as 'the premises'). I am aware that those risks, dangers and hazards include but are not limited to the unpredictable and dangerous nature of livestock and other animals which may be present on or in the vicinity of the premises. I freely accept and fully assume all such risks, dangers or loss resulting from such risks, dangers and hazards.

In consideration of the Friends of Sunnybrook Farm Society permitting my child to participate in the programs offered on the premises, I hereby agree as follows:

- 1) To assume and accept all risks, dangers and hazards that may arise in connection with the children's attendance at or use of Sunnybrook Farm Museum;
- 2) To waive any and all claims that I may have against the Friends of Sunnybrook Farm Society, its employees, agents and representatives;
- 3) To release the Friends of Sunnybrook Farm Society from any and all liability for any loss, damage, injury or expense that I or my next of kin may suffer or incur as a result of my child's attendance at or participation in the programs at the Sunnybrook Farm Museum, on the part of the Friends of Sunnybrook Farm Society, its volunteers, employees, agents and representatives;
- 4) To hold harmless and indemnify the Friends of Sunnybrook Farm Society from any and all liability for property damage, personal injury or death suffered by my child or by a third party as a result of my child's attendance at or use of the premises;
- 5) That this Release and Indemnity Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, and assigns, in the event of my death or the death of my child;
- 6) That although there may not be any supervision by the Friends of Sunnybrook Farm Society of any activity occurring at the Sunnybrook Farm Museum my child will obey all directions and instructions given my to child by the Friends of Sunnybrook Farm Society or its employees or agents;
- 7) My child's participation in programs at Sunnybrook Farm Museum may be subject to cancellation or removal by the Friends of Sunnybrook Farm Society if my child, in the opinion of an authorized representative of the Friends of Sunnybrook Farm Society fails to observe any directions or instruction given to my child;
- 8) The Friends of Sunnybrook Farm Society has the right to refuse access to the Museum or any part of the premises in their sole discretion.

I have read and understood the Release and Indemnity Agreement prior to signing and I am aware that by signing this document I am affecting the legal rights and liabilities of myself, my heirs, next of kin, executors, administrators and assigns in relation to the Friends of Sunnybrook Farm Society. (Parents or Guardian must sign for persons under 18, or under a disability).
